

INFORMATION ON THE PROTECTION OF GUESTS PERSONAL DATA

Please be advised that the administrator of your personal data is FIRMA HANDLOWA RAFAŁ KARP with its registered office in Dąbrowa 2 (97-217 Lubochnia) entered in the Central Register and Economic Information of the Republic of Poland, NIP 7732294803, REGON 100762793. Your personal data are processed based on the provisions of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 the so-called General regulation on the protection of personal data (GDPR) and provisions of national law.

Your personal data will be processed for the purpose of:

- entry to the premises of FIRMA HANDLOWA RAFAŁ KARP,
- ensuring the safety of facilities and property belonging to FIRMA RAFAŁ KARP,
- protection of the confidentiality of information, the disclosure of which could be exposed by the TRADE COMPANY RAFAŁ KARP to the detriment,
- Achieving the goals resulting from the legitimate interests of the TRADE COMPANY RAFAŁ KARP

Please be advised that monitoring is carried out on the premises of FIRMA HANDLOWA RAFAŁ KARP video in the form of a constant preview performed by a company providing physical protection services and in the form of continuous recording for later verification. The monitoring covers the COMPANY area HANDLOWA RAFAŁ KARP.

Providing data is voluntary, but necessary to implement the above-mentioned purposes including is necessary for entry the premises of FIRMA HANDLOWA RAFAŁ KARP. In the event of refusal to provide personal data for the above-mentioned purpose, it will be necessary for you to leave the COMPANY premises immediately HANDLOWA RAFAŁ KARP.

The recipient of your personal data may be entities cooperating with the COMPANY HANDLOWA RAFAŁ KARP in the scope of:

- physical security services,
- supply of IT systems,
- legal services, consulting and auditing.

The collected data will not be provided to third parties without your prior consent, unless their disclosure will be necessary due to the fulfillment of the legal obligation as well as implementation of legitimate interest FIRMA HANDLOWA RAFAŁ KARP.

In the event of providing consultancy services to the Administrator by entities located outside area of the EU and EEA, personal data may be made available to these entities to the United States on the basis of the Commission Implementing Decision (EU) 2016/1250 of July 12, 2016. adopted under Directive 95/46 / EC of the European Parliament and of the Council on adequacy protection provided by the EU-US Privacy Shield. The decision states that it is allowed transfer of data to entities in the United States that have adopted a set of protection rules

self-certification, by entering them on the list of entities that have self-certification under EU-US Privacy Shield. List of entities and information on the principles of processing

The data will be processed for the period of cooperation, time resulting from legal provisions and time resulting from protection against claims.

You have the right to access your data, correct it, rectify it, delete it, restriction of processing, transfer, objection, unless these rights are excluded on the basis of the relevant legal provisions. The data subject also has the right to file a complaint to the President of the Personal Data Protection Office.

In the event of granting the Administrator consent to the processing of data, it is possible withdrawal of consent, but the withdrawal of consent does not affect the processing of data carried out by the Administrator until the declaration of withdrawal of consent reached Administrator.
